Spring has finally arrived and the time has come to send out invoices for 2011 dues. The General Dues will be \$10 based on expected spending of \$791 across 67 assessable lots.

For Phase 2 & 3 lighting, we ended the year \$84 over target for the 2010 assessment. Based on current expenses, the expected expense will be \$2,480 for 2011. So based on a 31 lot base, the dues will be \$80 + \$10 General Dues = \$90 per lot.

Annual HOA Meeting – Tuesday, April 26th, 7pm at the Batavia Township Center at 1535 Clough Pike Front Entry Cleanup - Saturday, May 14th, 2011, 10am. Bring your gardening stuff.

This year we'll distribute 8 - \$10 gift certificates to the 1st 8 people that participate in the entry cleanup.

As requested, we now have a "NO OUTLET" sign on Winter Holly!

The vote on the change of the Covenants did not pass. Results are on the web site.

We have included a flyer from Forest Green Waste Service who charges only \$18 total per month, including a tote, for trash collection. This is far cheaper than CSI and Rumpke. (Treasurer's note: CSI had just raised mine to \$39 per month, and they would have price matched, but I just didn't trust them going forward.) Sign up by April 30th for a 1 year rate lock. Pricing goes up to \$21 per month May 1st.
